北月 Background

- 行政長官梁振英先生在其競選政綱中承諾,政府會成立金融發展局(金發局),以促進香港國際金融中心的進一步發展。
- ▶ 二零一三年一月,香港特別行政區政府成立金發局為高層 次及跨界別的諮詢機構,以就如何促進香港金融服務業的 更大發展,並為金融服務業制訂策略性發展路向,諮詢業 界並提出建議。
- 二零一三年一月十七日,行政長官委任史美倫女士為金發局主席,另又委任21人為金發局成員。其後,行政長官在二零一三年四月五日再委任34名非官方人士及兩名官方人士,加入金發局,以協助金發局轄下五個小組執行工作。該五個小組分別為政策研究小組、內地機遇小組、拓新業務小組、市場推廣小組,以及人力資源小組。
- ▶ 各個小組分別負責研究金融服務業的個別範疇,以及推 行有助發展的相關措施。工作範圍包括提出務實可行的 建議,以供政府、監管機構、業界及其他相關各方考慮;探 討香港在內地金融改革和內地市場與貨幣國際化的過程 中,所擔當的獨特角色;吸引資金流入本港的資本市場;推 廣香港金融服務業,使其廣為人識;以及培育本地人才。
- ▶ 行政長官於二零一五年一月十六日再度委任史美倫女士(主席)和14名現任成員,以及委任七名新成員,任期由二零 一五年一月十七日開始,為期兩年。
- ▶ 這份年報所涵蓋的期間由二零一四年四月一日至二零一五 年三月三十一日。

- ► The Chief Executive the Honourable C Y Leung pledged in his election manifesto to establish a Financial Services Development Council ("FSDC") under his Administration to facilitate the further development of Hong Kong's position as an international financial centre.
- ▶ In January, 2013, the Hong Kong Special Administrative Region (HKSAR) Government established the FSDC as a high-level, cross-sectoral advisory body to engage the industry and formulate proposals to promote the further development of Hong Kong's financial services industry and map out the strategic direction for development.
- ► The Chief Executive appointed Mrs Laura M Cha as Chairman and 21 members to the FSDC on 17 January, 2013. Further appointments of 34 non-official members and two ex-officio members were made on 5 April, 2013 to serve on five Committees, namely the Policy Research Committee; the Mainland Opportunities Committee; the New Business Committee; the Market Development Committee and the Human Capital Committee.
- ➤ The Committees were formed to study specific areas of the financial services industry and propose relevant development initiatives and pragmatic action points for the Government. In the process, the Committees engage regulators, industry and other stakeholders to examine Hong Kong's unique role in the Mainland's financial reform and the internationalisation of its market and currency, attract funds to our capital markets, raise the profile of Hong Kong's financial services industry, and build capacity of our homegrown professionals.
- ► The Chief Executive re-appointed Mrs Laura M Cha (Chairman) and fourteen incumbent members to the FSDC on 16 January, 2015, and appointed seven new members to the Council for a term of two years from 17 January, 2015.

▶ This report covers the period from 1 April, 2014 to 31 March, 2015.



金融發展局(金發局)成立至今已有兩年。作為諮詢組織,金 發局的歷史也許相對尚淺,但我們會繼續勉力為本地業界及 市場拓展商機,進一步推動香港這個國際金融中心的發展, 無時或怠。

金發局在二零一四至一五年度向政府提交了七份研究報告,並公布周知。這些報告涵蓋多個課題:拓展內地機遇及人民幣商機;優化本港首次公開招股及證券交易平台;推動香港金融服務;以及發展人力資源。金發局在上述報告和二零一三年十一月發布的六份研究報告中,提出多項措施,我們樂見當中不少新猷已獲政府和有關監管機構採納,付諸實施。

金發局會再接再厲,與業內不同界別保持緊密聯繫,繼續擔當 政府與專家和從業員的溝通橋樑,集思廣益,協力進一步推 動本地市場發展。

金發局也與其他相關各方合作,贊助或參與多個本地、內地和海外的宣傳活動,藉以推廣香港作為主要環球金融中心的地位。舉辦這類活動的城市包括內地的博鰲、北京及廣州,海外的巴黎,當然少不了香港。金融世界瞬息萬變,這類活動讓參與者知悉香港的最新情況,並宣傳香港的國際金融網絡優勢,卓見成效。

另一項重點工作,就是發展人力資源,我們在來年會繼續這方面的工作。金發局近期發表的其中一份研究報告指出,香港金融服務業大有可為,機遇無限。本港的畢業生及專業人士有許多競爭優勢,配合來自海外的人才,相輔相成。謀事在人,匯聚人才,正是香港的優勢所在。

過去兩年,金發局全體成員及小組成員為各項工作盡心盡力, 貢獻良多,我在此謹衷心致謝,期望繼續與諸位成員齊心協力,進一步推動本地金融服務業發展,以鞏固並提升香港這個 亞洲首屈一指金融中心的地位。

The Financial Services Development Council (FSDC) has now been in existence for two years. As an advisory body, it is perhaps still relatively new. Nonetheless, we continue to be busy at work, seeking further growth for our industry and markets, and the development of Hong Kong as an international financial centre.

During 2014/15, the FSDC published and submitted to the Government seven reports. These reports covered a range of subjects such as leveraging Mainland and Renminbi opportunities, enhancing our IPO and equity trading platforms, promoting Hong Kong's financial services, and developing human capital. We are pleased to see that the Government and relevant regulators have taken forward a number of measures related to these as well as our six previous reports (published in November 2013).

The FSDC will continue to maintain constant contact with the different segments of our industry and to serve as a platform for the Government to gather experts' and practitioners' views on the further development of our markets.

In collaboration with other stakeholders, the FSDC also sponsored or participated in numerous local, Mainland, and overseas marketing campaigns to promote Hong Kong's position as a key global financial centre. Events took place in Boao, Beijing, Guangzhou, Paris, and, of course, at home in Hong Kong. Given the fast changing world of finance, these efforts to keep Hong Kong in everyone's view and to articulate our strengths within the international network were very well received.

Another area of our focus has been — and will continue to be in the next year — the development of human capital. As one of FSDC's recent reports highlighted, there are plenty of opportunities in our industry. Hong Kong graduates and professionals have many competitive advantages and are, of course, complemented by talents coming from outside to join us. This is a key strength of ours; it is always the people who make the real difference.

I wish to express my appreciation to all Council and Committee Members for their dedication and contribution over the past two years. I look forward to continuing to work with members to build on FSDC's momentum for the further development of our industry so as to maintain and elevate Hong Kong's position as Asia's preeminent financial centre.

金融服務業支持政府成立高層諮詢組織,以支援業界持續發展。有見及此,香港特區政府在二零一三年一月成立金發局,就如何推動香港金融服務業的更大發展及金融產業策略性發展路向,諮詢業界並提出建議。金發局會致力凝聚業界力量,集思廣益,並為業界推廣代言和培育人才。

目標

金發局的工作目標是:

- 就開拓金融市場和加強香港國際金融中心競爭力的策略和措施,向政府提供諮詢意見和 建議;
- 2. 為相關各方發表意見提供渠道,並為金融服務界爭取權益;
- 3. 支持金融服務界提升從業人員的核心競爭能力和專業技能;以及
- 4. 在內地和海外推廣本地金融服務業和香港的國際金融中心優勢。

職能節圍

金發局的職能範圍如下:

- 1. 進行政策研究和業界調研,制訂建議供政府和監管機構參考;
- 2. 與監管機構和行業團體共同探討金融服務業持續多元發展的機遇和掣肘;
- 3. 與內地和海外相關機構保持溝通,支持香港金融服務業開拓新市場和新業務;
- 4. 與教育培訓機構、行業團體和業界合作,提升從業人員的技術和專業知識;以及
- 5. 通過舉辦研討會、路演、印發刊物以及積極參與國際活動,在內地和海外推廣香港的金融服務業和國際金融中心功能。

金發局下設有五個小組,包括政策研究小組、內地機遇小組、拓新業務小組、市場推廣小組以及人力資源小組。各個小組深入研究金融業的個別範疇,制定工作方向及計劃,並向政府提供意見和建議。

The FSDC was established by the HKSAR Government in January, 2013 in response to the financial services industry's call for a high-level government advisory body to support the sustained development of the industry. The FSDC engages the industry and formulates proposals to promote the further development of Hong Kong's financial services industry and map out the strategic direction for the development of Hong Kong as an international financial centre. It acts as a focal point of views and melting pot of ideas, as a champion and ambassador of the industry, and as a capacity builder.

Objectives

The FSDC aims to:

- advise the Government on strategies and measures to expand the scope of our financial markets and enhance the competitiveness of Hong Kong as an international financial centre;
- 2. provide a channel for stakeholders to express views and champion the interests of the financial services industry;
- support the financial services industry in developing the core competence and knowledge of its practitioners; and
- promote our financial services industry and Hong Kong as an international financial centre on the Mainland and overseas.

Terms of Reference

The terms of reference of the Council are:

- 1. To conduct policy research and industry surveys for the formulation of proposals to the Government and regulators;
- 2. To work with regulatory and trade bodies to identify new opportunities for, and any constraints on, the sustainable growth and diversity of the financial services industry;
- 3. To maintain a dialogue with the relevant bodies on the Mainland and overseas to support Hong Kong's financial services industry in accessing new markets and growth areas;
- 4. To facilitate the upgrading of skills and expertise through collaboration with education and training institutions, trade bodies and practitioners; and
- 5. To promote, on the Mainland and overseas, our financial services industry and Hong Kong as an international financial centre through seminars, road shows, publications, and through active participation in international events.

The FSDC's work is underpinned by the five Committees established, namely, Policy Research; Mainland Opportunities; New Business; Market Development; and Human Capital. The Committees are tasked to study specific areas in depth, formulate work directions and plans with a view to providing advice and recommendations to the Government.







繼二零一三年十一月發表首批共六份研究報告後,金融發展局(金 發局)在二零一四至一五年度再發表七份研究報告,並已把報告提 交政府考慮。憑藉金發局成員所擁有的種種專長和淵博知識,以及 在金融服務業各個領域所建立的廣泛網絡,金發局在年內深入探討 不同課題,包括如何進一步鞏固本港的集資及證券投資平台、拓展 內地機遇及人民幣商機、推廣香港國際金融中心的地位,以及為金融業發展人力資源,並發表相關報告。報告提出了一系列建議,供 政府、監管機構、業界及相關人士考慮。

二零一四年四月,金發局發表兩份分別題為《金融發展局的推廣活動》及《金融培訓課程試點計劃》的報告,強調局方會致力與相關機構建立合作關係,以推廣本港金融服務和培育本地金融專才。具體而言,局方在《金融發展局的推廣活動》報告中,列述擬在二零一四至一五年度贊助和協辦香港貿易發展局的年度重點推廣活動;另在《金融培訓課程試點計劃》報告中,表明會擔當促進協調的角色,協助本地數家培訓及教育機構開辦以應屆畢業生及從業員為對象的實務培訓課程。

此外,金發局也發表了兩份有關發展本地集資及證券投資平台的研究報告。其一為在二零一四年六月發表的《定位香港為國際首選的首次公開招股中心》,內容重點是探討哪些措施可助吸引海外公司選用香港的首次公開招股平台,與香港作為內地公司首選上市地點的地位互補。基於香港不但擁有健全的法律制度,鄰近亞洲其他高速發展的經濟體,並且是國際投資者和資金的匯聚之處,報告建議有關當局考慮推行以下措施:適當分設不同市場類別,令不同類型的投資者及發行人獲得較佳的配對;在為股東提供適當保障的前提下,配合股權結構及管理方式的革新;把香港發展成為特定行業的股票發行中心。報告也討論了幾個海外發行人相關的問題,例如放寬公開存檔規定(即所謂安全港)、加強跨境監管執法、簽訂避免



雙重課稅協定、設立途徑給股東追索補償,以及推行無紙證券市場制度。報告還建議有關當局適當地檢討某些新股上市流程,包括與交收周期和安排、回撥機制及監管基 石投資者等。

另一份有關報告為《香港的權益披露制度》,在二零一四年十二月發表。部份市場參與者十分關注權益披露制度的相關問題,包括披露規則過於複雜,相應的合規成本高昂;披露規則相當容易令人誤墮法網,遭受刑事檢控;以及披露權益的存檔通知對投資大眾來說不易明白。為消除他們的疑慮,報告提出多項建議,務求進一步改善本地證券市場的守則和規例。建議包括對現行規則作各種技術性修訂,以簡化匯報責任,並考慮把違反披露規則改為非刑事罪行(有犯罪意圖者除外);以及研究是否有需要徹底重訂整個制度。

在二零一四年九月發表的有關《內地與香港關於建立更緊密經貿關係的安排》的政策發展建議之報告,探討內地機遇和人民幣商機。報告提出九項具體政策建議,包括在《內地與香港關於建立更緊密經貿關係的安排》的框架下,引入負面清單的概念,以及其他建議,進一步向銀行、保險、資產管理和證券及期貨行業開放內地市場。

於二零一四年十二月發表的《發展香港成為離岸人民幣再保險中心》報告,則討論發展人民幣再保險業務的措施。報告建議一些有助香港發展人民幣再保險業務的措施,包括:為香港的再保險商提供可循環使用的人民幣合格境外機構投資者計劃特定債券投資額度,利便這些公司進入內地投資市場,使其得以提高管理資產與負債的能力;鼓勵香港的再保險商和經紀人承保或經營人民幣再保險業務。香港的人民幣再保險業務如能蓬勃發展,不但有助推動人民幣國際化,而且有利於內地保險公司分散風險,以及讓它們接觸和使用更多海外的國際再保險商和專業保險公司的服務。

除了發表上述幾份研究報告外,金發局繼續密切跟進內地的金融/經濟發展情況和相關改革,並就多個議題,例如中國企業走出去、自由貿易和經濟特區,以及證券化市場,擬備工作文件,供成員討論和政府參考。

要鞏固香港作為札根亞洲、首屈一指金融中心的地位,其中一項關鍵因素是建立培育制度,源源不絕供應人才。二零一五年一月,金發局發表題為《發展香港金融服務業人力資源》的報告。報告指出,雖然香港人才濟濟,各有所長,較亞洲其他金融中心優勝,但金融服務業多個界別在招攬和挽留經驗豐富的員工方面都有困難。在私人銀行和保險業,以及畢業生不甚了解的中台部門/後勤部門,人才短缺的情況尤其嚴重。報告建議循四個方面推行措施,以提高本地金融服務業從業員的專業水平,包括加深各界人士對金融服務業各類職位的了解;推動學術界和業界加強合作,協助有志從事金融服務業的專才好好裝備自己;邀請業界專才及從業員在培訓活動中分享心得;以及解決影響香港整體就業環境的一些結構性問題。

概括而言,金發局在研究報告內提出的建議,反映局方就不同課題諮詢業界期間收集所得的意見。有關建議都經過金發局成員及其小組成員詳細研究,反覆討論。我們樂見政府及監管機構繼續跟進金發局所提出的一些建議。金發局研究報告所涵蓋的多個課題,均有令人鼓舞的進展,包括:

金發局研究報告

二零一四至一五年間的 進展

《關於加快建設香港離岸人民幣中心的建議》

金管局把七家活躍參與離岸人民幣 市場的銀行指定為一級流動性提 供行,有關安排由二零一四年十月 二十七日起生效。獲指定為一級流 動性提供行的銀行,會致力運用和 發展香港的環球金融平台,藉以拓 展其離岸人民幣業務,而金管局則 會為每家一級流動性提供行提供人 民幣回購協議設施,利便他們管理 流動性。

香港居民每日只可兌換 2 萬元人 民幣的限額,由二零一四年十一月 十七日起取消,香港居民參與滬港 股票市場交易互聯互通機制(滬港 通)及其他人民幣金融交易會更為 方便。



二零一四年十二月,香港交易及結算所有限公司(香港交易所)推出三種以人民幣交易的商品期貨合約,包括倫敦鋁期貨小型合約、倫敦鋅期貨小型合約及倫敦銅期貨小型合約。

《內地金融業的發展、改革與香港金融中心地位的鞏固、提升》

自二零一四年十月開始,人民幣清算行的即日人民幣清算服務時間,由每日15小時進一步延長至20.5小時(直至翌日凌晨五時),以涵蓋歐美時區。

二零一四年十一月十七日,滬港通正式開通,使滬港兩地的股票市場得以互通。合資格的內地投資者可直接投資於香港股票市場,而香港及海外投資者也可直接投資於上海股票市場。

《發展香港成為房地產投資信託基金的集資中心》

證券及期貨事務監察委員會(證監會)經廣泛徵詢業界及公眾的意見後,在二零一四年八月公布經修訂的《房地產投資信託基金守則》,使這類基金在相關的限制下,可彈性投資物業發展活動(不得超過這類基金資產總值的10%)及金融工具。有關措施讓房地產投資信託基金繼續成為主要產生定期租金收入的投資工具。

《為香港的開放式投資公司設立法律及監管框架的建議》

在二零一三至一四年度的《政府財政預算案》中,財政司司長宣布引入以公司形式成立的開放式基金(公司型開放式基金)。政府現正擬訂具體立法建議,藉以為公司型開放式基金的新結構提供法律框架。

《就〈二零一三至一四財政年度政府 財政預算案〉有關私募基金的稅務 寬免和反避稅措施建議概要》 二零一五年三月,政府向立法會提 交條例草案,建議私募基金可與離 岸基金看齊,同樣獲豁免繳付利得 稅。這是二零一三至一四年度《政 府財政預算案》宣布的另一項措施。

《定位香港為國際首選的首次公開招股中心》

二零一五年三月十八日,有關在香港推行無紙證券市場制度的修訂條例獲得通過。證監會計劃在二零一五年下半年就制度的實施規則諮詢公眾。

二零一四年八月,香港交易所發表了有關不同投票權架構的概念文件,徵求對以下建議的意見:凡已在或有意在香港聯合交易所上市的公司,可准予採用給予若干人士與其持股量不成比例的投票權或其他相關權利的管治架構(即不同投票權架構)。

《有關〈內地與香港關於建立更緊密經貿關係的安排〉的政策發展建議》

《關於內地在廣東與香港基本實現服務貿易自由化的協議》由二零一五年三月一日起實施;協議採用正面和負面清單的混合模式表述開放措施。



《發展香港金融服務業人力資源》

財政司司長在二零一四至一五財政年度《政府財政預算案》中,要求財經事務及庫務局徵詢業界對人才培訓的意見。其後,財政司司長在二零一五至一六財政年度《政府財政預算案》中公布撥款一億元,為保險和資產財富管理兩個界別推行一項為期三年的先導計劃。在先導計劃下,政府與業界會合作推出各項活動和提供實習機會,讓社會(特別是學生)加深認識該兩個界別內不同崗位的性質及晉升前景,並會強化持續進修課程的內容,以及資助從業員修讀這些課程。

Following its first six research reports published in November, 2013, the FSDC released another seven reports in 2014/15 and submitted them to the Government. Fully leveraging the breadth and depth of Members' expertise and their extensive industry network, the reports covered a variety of subjects including further enhancing our fund raising and securities investment platform, exploring more Mainland and RMB opportunities, promoting Hong Kong's position as an international financial centre, and developing human capital in the financial services industry. The reports provided recommendations to the Government, regulators, and industry stakeholders for their consideration.

In April, 2014, the FSDC released two reports entitled "Promotional Activities by the Financial Services Development Council" and "Pilot Scheme for Training Courses" respectively, emphasising FSDC's collaborative relationships with relevant organisations in promoting Hong Kong's financial services and nurturing local financial talents. The "Promotional Activities by the Financial Services Development Council" set out the FSDC's plan to support and co-sponsor a number of key promotional events organised by the Hong Kong Trade Development Council during 2014/15, while the "Pilot Scheme for Training Courses" set out the FSDC's facilitator role in assisting a number of local training and education institutions in developing practical training courses for both fresh graduates and practitioners.



The FSDC also published two research reports on developing the local fund raising and securities investment platform. The report on "Positioning Hong Kong as an international IPO Centre of Choice", released in June, 2014, highlighted measures that could help strengthen Hong Kong's IPO platform and attractiveness to overseas companies and complement our position as the premier listing destination for Mainland companies. Building on Hong Kong's reputable legal system, proximity to fast-growing economies in Asia, and the clustering of international investors and capital, the report recommended that consideration be given to: introducing distinct market segmentation to enable better matching between different types of issuers and investors; accommodating innovations in shareholding and management structure subject to appropriate shareholder safeguards; and developing Hong Kong as a hub for issuers in specific industries. The report also raised a few issues relevant to overseas issuers, including public filing safe harbours, strengthening cross-border regulatory enforcement, double taxation treaty network, and channels for shareholders' recourse. The report further suggested conducting suitable review on procedural issues including settlement cycle, clawback mechanism, and regulation of cornerstone investments.

Another report on "Disclosure of Interests Regime in Hong Kong", published in December, 2014, provided recommendations on further improving the practices and regulations in the local securities market to address some market participants' concerns about the overly complex disclosure rules and



the ensuing compliance costs, relatively high risk of inadvertent criminal sanctions and difficulty for the investing public to understand the disclosure filing. The report proposed various technical improvements on the existing rules to streamline the reporting obligations and suggested decriminalising breaches of disclosure rules except those with criminal intent. The report asked the regulators to consider whether a comprehensive re-write of the regime was warranted.

Regarding Mainland and RMB opportunities, the report on "Policy Development Proposals on the Mainland and Hong Kong Closer Economic Partnership Arrangement (CEPA)" released in September, 2014 provided nine specific policy recommendations, including introducing the negative list concept to CEPA as well as recommendations on granting enhanced access to the Mainland markets for companies in the banking, insurance, asset management and securities and futures sectors.

Published in December, 2014, the report on "Developing Hong Kong as an Offshore Renminbi-denominated Reinsurance Centre" discussed measures to develop RMB-denominated reinsurance business. The report suggested initiatives to provide Hong Kong-based reinsurers recyclable RMB Qualified Foreign Institutional Investors bond quota, to enable them to tap into the Mainland investment market for better asset-liability management, and to encourage Hong Kong-based reinsurers and brokers to write or transact RMB reinsurance. A vibrant RMB reinsurance business in Hong Kong would further contribute to the internationalisation of RMB, and help Mainland insurers to diversify their exposures and offer them better access to a wider range of international reinsurance providers and specialist carriers currently based overseas.

Apart from the two reports above, the FSDC closely followed various financial/economic developments and reforms in the Mainland. A number of working papers on such topics as Chinese enterprises "Going Global", Free Trade Zones, and securitisation market had been produced for Members' deliberation and for the Government's reference.

Developing a sustainable talent model is a key enabler for Hong Kong in consolidating our status as the preeminent financial centre based in Asia. The report on "Developing Hong Kong's Human Capital in Financial Services" released in January, 2015, noted the difficulty in finding and keeping seasoned employees across many segments of the financial

services industry, notwithstanding Hong Kong's favourable position among Asian financial centres in the size and diversity of its talent pool. The shortage of talent was especially acute in private banking and insurance, as well as mid/back office positions in the sectors less familiar to young graduates. The report proposed measures in four areas to raise the bar for Hong Kong's financial talent pool, namely, enhancing graduates' understanding of various career choices in the financial services industry, stepping up collaboration between academia and the industry to better equip aspiring financial professionals, engaging industry professionals and practitioners in training activities, and addressing structural issues that affect Hong Kong's general employment environment.

In general, proposals put forward in the FSDC's reports reflected industry views arising from our engagement with stakeholders on different subjects. The recommendations had been thoroughly deliberated by members of the FSDC Council and Committees. We are pleased that the Government and the regulators have continued to follow up on some of the recommendations made by the FSDC, and welcome the encouraging development on a number of subjects covered by our reports -

FSDC Reports

Development during 2014/15

Proposals to Advance the Development of Hong Kong as an Offshore Renminbi (RMB) Centre Hong Kong Monetary Authority (HKMA) designated seven banks active in the offshore RMB (CNH) market as Primary Liquidity Providers (PLPs), with effect from 27 October, 2014. Banks designated as PLPs are committed to developing Hong Kong as the global platform to support their offshore RMB businesses, and HKMA in return will offer a repo line to each of the PLPs to facilitate their liquidity management.

On 17 November, 2014, RMB conversion limit for Hong Kong residents of RMB20,000 per day was removed, making it more convenient for Hong Kong residents to participate in Shanghai-Hong Kong Stock Connect programme and other RMB financial transactions.



The Hong Kong Exchanges and Clearing Limited (HKEx) introduced in December, 2014 three commodities contracts traded in RMB – London Aluminium Mini Futures, London Zinc Mini Futures and London Copper Mini Futures.

Development and Reform of Mainland China's Financial Sector and the Strengthening and Enhancement of Hong Kong's Pivotal Role as a Financial Centre With effect from October, 2014, the RMB Clearing Bank has further extended the RMB clearing services from 15 hours to 20.5 hours daily (i.e. until 5am of the next day) to cover both the European and American time zones for same-day value payment.

The Shanghai-Hong Kong Stock Connect programme, which provides stock market trading links between Shanghai and Hong Kong, was launched on 17 November, 2014, allowing eligible Mainland investors to invest directly in Hong Kong's stock market, while Hong Kong and overseas investors are able to do the same in Shanghai's stock market.

Developing Hong Kong as a Capital Formation Centre for Real Estate Investment Trusts (REITs) Following extensive consultation with the industry and the public, the Securities and Futures Commission (SFC) promulgated a revised Code on Real Estate Investment Trusts in August, 2014 to give REITs the flexibility to invest in property development activities (up to 10% of the REITs' gross asset value) and financial instruments, subject to relevant restrictions such that a REIT will maintain its profile as primarily a recurrently rental income generating vehicle.

Proposals on Legal and Regulatory Framework for Openended Investment Companies in Hong Kong The Financial Secretary, in his 2013-14 Budget, announced to introduce open-ended fund company (OFC) in Hong Kong. The Government is formulating detailed legislative proposals to provide the legal framework for the new OFC structure.

Synopsis Paper Proposing Tax Exemptions and Anti-avoidance Measures on Private Equity Funds in the 2013-14 Budget The Government in March, 2015 introduced a Bill into LegCo to allow private equity funds to enjoy profits tax exemption available to offshore funds, which is another initiative announced in the 2013-14 Budget.

Positioning Hong Kong as an International IPO Centre of Choice An Amendment Ordinance was enacted on 18 March, 2015 to enable the introduction of an uncertificated securities market regime in Hong Kong. The SFC plans to consult the public on the implementation rules in the latter half of 2015.

HKEx published a concept paper on weighted voting rights in August, 2014 to seek views on whether governance structures that give some shareholders voting power or other rights not in proportion to their shareholdings (weighted voting right structures) should be permissible for companies listed or seeking to list on the HKEx.

Policy Development Proposals on the "Mainland and Hong Kong Closer Economic Partnership Arrangement" The Agreement between the Mainland and Hong Kong on Achieving Basic Liberalisation of Trade in Services in Guangdong, implemented on 1 March, 2015, adopted a hybrid approach of negative and positive listings in further liberalisation measures.



Developing Hong Kong's Human Capital in Financial Services

The Financial Secretary, in his 2014-15 Budget, tasked the Financial Services and the Treasury Bureau to consult the industry on manpower training needs. The Financial Secretary announced in his 2015-16 Budget the allocation of \$100 million to launch a three-year pilot scheme for insurance and asset and wealth management services, under which the Government would collaborate with the industry to organise activities and provide internship opportunities to allow the community, in particular students, to have a better understanding of the nature and career prospects of different jobs in the two sectors. The Government and the industry would also enhance the contents of continuing professional development programmes, and provide financial support to encourage practitioners to enrol in these programmes.

博鰲亞洲論壇 2014 年年會 二零一四年四月八至十日

Boao Forum for Asia Annual Conference 8–10 April, 2014 The Chairman of the FSDC, Mrs Laura M Cha and Members of the FSDC including Professor K C Chan, Secretary for Financial Services and the Treasury and Mr Benjamin Hung, Standard Chartered Bank (Hong Kong) Limited's Regional Chief Executive Officer for Greater China, participated as panelists at one of the breakout sessions at the Boao Forum for Asia Annual Conference 2014. Under the theme "The Future of Hong Kong as an International Financial Centre", the session highlighted the competitiveness, opportunities and challenges of Hong Kong as a leading financial centre in Asia as well as the role of Hong Kong in the internationalisation of the Renminbi.

FSDC delegation to Beijing 3–4 September, 2014

FSDC conducted a study tour to Beijing in September, 2014, and visited the China Securities Regulatory Commission, State-owned Asset Supervision and Administration Commission as well as a few state-owned and private enterprises. The aim of the visit was to gather first-hand information from relevant authorities and enterprises in the Mainland on issues relating to the overseas investment and financing activities of Mainland enterprises. Members



also took the opportunities to encourage enterprises to use Hong Kong as their hub for overseas expansion and treasury operations.

10th Pan-Pearl River Delta Regional Co-operation and Development Forum 12 October, 2014 Mr Chen Shuang, Member of the FSDC, represented the Council and spoke on "Hong Kong's Financial Platform in Facilitating Mainland Enterprises' Going-out and Internationalisation" at the "10th Pan-Pearl River Delta Regional Co-operation and Development Forum" in Guangzhou. The event was jointly organised by the HKSAR Government and the Hong Kong Trade Development Council (HKTDC), and was well received with an enthusiastic attendance of over 400 industry representatives in the Mainland.



Think Asia, Think Hong Kong 28–29 October, 2014

FSDC co-organised a financial session with the HKTDC at the Hong Kong signature campaign - "Think Asia, Think Hong Kong" held on 28, October in Paris. A panel was organised under the theme "Hong Kong: Asia's Premier Asset and Wealth Management Centre", at which Mrs Laura M Cha provided an overview on the asset management business in Hong Kong. It was followed by a lively discussion panel moderated by FSDC Member Mr Mark McCombe, Blackrock's Global Head of Institutional Client Business and Chairman of Alternative Investors. Panelists from the asset and wealth management industry discussed Hong Kong as an ideal platform for funds and wealth managers to explore investment opportunities in the region and manage Asian capital. The advantages that investors and corporations could gain by diversifying their investment portfolio through the Hong Kong platform were also highlighted.



FSDC Career Day 9 November, 2014



The inaugural "FSDC Career Day" was held on 9 November to provide a platform for university students to understand the different types of jobs in the financial services industry through experience-sharing by leading practitioners. Comprising keynote speeches, discussion panels and breakout sessions, the half-day event offered practical tips on job search and how to be prepared for a career in finance. The event was attended by over 420 students from ten universities.



Asian Financial Forum 19–20 January, 2015



The FSDC co-sponsored the "Asian Financial Forum" on 19-20 January organised by the HKSAR Government and the HKTDC. The Forum is a flagship annual event in Hong Kong for the region's financial circle, and attracted a record of over 2,600 participants this year. A breakfast panel sponsored by the FSDC was held on 20 January under the theme "Hong Kong: Asia's Premier Asset and Wealth Management Centre". The panel recorded an attendance of 900 international business and financial services professionals from Hong Kong, the Mainland and overseas. Following a welcoming address by Mrs Laura M Cha, FSDC Member Mr Benjamin Hung, moderated a discussion panel on opportunities in asset and wealth management business arising from Hong Kong's position as the gateway to the burgeoning wealth in the Mainland and the rest of Asia. A "Hong Kong Booth" was also set up at the Forum jointly by the FSDC and InvestHK to showcase Hong Kong's advantages as Asia's premier international financial centre.



Industry Engagement Meetings April 2014–March 2015 During 2014/15, the FSDC arranged 10 luncheon meetings with industry organisations from various sectors of the financial services industry to discuss issues of their concerns. The insight from practitioners will be useful to the FSDC in shaping its agenda in enhancing the competitiveness of individual sectors and the industry as a whole.
